OVERVIEW

Life Membership is the highest accolade available to recognise the exceptional contribution of individuals to the Real Estate Institute of Queensland (**REIQ**). It is awarded in recognition of long, continuous, and outstanding meritorious service to the REIQ.

It is only to be awarded in exceptional circumstances.

Each year the REIQ Board of Directors considers whether it wishes to grant Life Membership. To that end, the REIQ Board of Directors is seeking recommendations for Life Membership from REIQ Members and the broader community.

CRITERIA

To be considered for Life Membership, an individual should have demonstrated significant, sustained, and high-quality service to the real estate profession and/or the REIQ.

The following criteria is provided by way of guidance:

- 1. The nominee will be a current and financial Fellow Member of the REIQ;
- 2. The nominee will have a minimum of 25 years (not necessarily continuous) in good standing; or
- 3. The nominee will be an Individual Fellow Member who has demonstrated an exceptional contribution of service to the REIQ over a significant period of time. This may include service by way of participating in and/or undertaking in the following roles:
 - a. serving as an REIQ Board Director;
 - b. involvement on REIQ Committees and Chapter Committees;
 - c. acting as a Zone Chair;
 - d. volunteering or representing the REIQ in some other way.
- 4. The nominee will have consistently demonstrated a professional and respectful attitude and demeanour that reflects dedication to the values of the REIQ;
- 5. The nominee has been a positive role model and has displayed leadership and a commitment to service to the real estate profession;
- 6. The nominee has throughout their membership, acted in the best interests of the REIQ and the real estate profession; and
- 7. The nominee's conduct positively reflects on the REIQ.



IMPORTANT MATTERS TO NOTE

Members should be aware that:

- it is not necessary for a Life Membership to be granted each year; and
- the final decision in relation to granting Life Membership rests with the Board of Directors.
